



NOTICE TO APPLICANTS FOR RESIDENTIAL LOANS – January 1, 2012

Capital Farm Credit, ACA is in compliance with the Secure and Fair Enforcement for Mortgage Licensing Act (the S.A.F.E. Act). Part of our compliance activities includes registering Mortgage Loan Originators (MLO) with the National Mortgage Loan System’s registry (Registry). The United States Congress designed and implemented the requirements of the S.A.F.E. Act to aggregate and improve the flow of mortgage loan originations; enhance consumer protections; support anti-fraud measures; and provide consumers with easily accessible information at no charge regarding the employment history of, and publicly adjudicated disciplinary and enforcement actions against, mortgage loan originators. The Registry maintains both public and private information about MLOs. Only those members of the lending staff that have completed the registration process and have been issued a unique MLO number are authorized to make loans to applicants for the purpose of purchasing, refinancing or constructing a dwelling.
